What is a New Hampshire charter school?

- Charter schools are open-enrollment, public schools of choice.
- They are mission driven and created to fulfill a need.
- * For state authorized charter schools, students may attend any charter school in the state and are not limited by zip code.
- Charter schools are independent, tuition free.
- * Charter schools are accountable for both academic results and fiscal practices.

Charter School Authorization

District Authorized- This process is used when a town or local district wishes to open a public charter school within the resident district. This avenue affords the town and/or district more control over the charter school.

State Authorized- Using this approach the charter school applicant applies directly to the New Hampshire State Board of Education for authorization to open a public charter school. Applications to open a state authorized charter school may be submitted or "sponsored" by local teachers, groups of parents or non-profit entities. (RSA 194-B:3a)

Funding Comparison Public Schools in New Hampshire

According to the NH Department of Education, the State Average Cost Per Pupil to educate a child in New Hampshire in 2019 was \$16,346.45.

Fiscal Relationship: Traditional Public Schools to Charter Schools (State Authorized)

Special Education: Local traditional school district legally and financially responsible for special education students in charter schools.

Staff: NH law allows for traditional public school districts and charter schools to enter into agreements regarding sharing of staff.

Facility: NH law allows for traditional public school districts and charter schools to enter into agreements regarding use of facilities.

Tuition Agreements: NH law allows for traditional public school districts and charter schools to enter into agreements regarding tuition.

Conclusions and Recommendations

Conclusions:

- Charter schools are underfunded public schools.
- Current model works when law is followed.

Recommendations:

- 1. Increase State Adequacy Aid for all public schools and maintain the "Additional Grant" for public charter schools.
- 2. Direct local funding to follow the child as it does in other state funding of charter schools at 80% of the average in district cost per pupil as the law was originally intended.
