Good afternoon,

I write to you regarding HB 10, which proposes to reduce the business profits and business enterprise taxes. While I certainly share in the overall goal of lowering business related taxes in New Hampshire, as a municipal official I have concern about changes to the tax system during the current pandemic and related economic challenges. The State of New Hampshire has relatively few sources of revenue and has seen revenue collections decline during the past year; lowering these taxes will likely only further shrink State revenues. This is a concern on the local level because municipalities rely on continued – and hopefully increased – aid from the State. Reductions in State revenue will likely mean less revenue going back to the cities and towns across New Hampshire, which will directly lead to higher local property taxes and/or reductions in services.

I urge you to consider the implications of passing HB 10.
